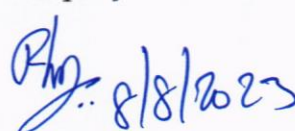

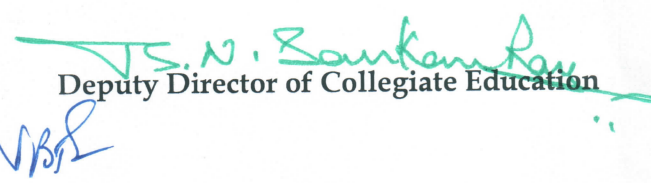

It is identified that no adequate workload is available in various subjects in Government Degree Colleges resulting in surplus staff. On the other hand, there is a sufficient workload in certain Colleges, but they are lacking faculty positions.

Under these circumstances, **Sri. T.Srinivas**, Lecturer in **Statistics** who has been identified as surplus at **Government Degree College, Piler** is hereby deployed to work at **SKR & SKR Government Degree College, Rajampet, YSR Kadapa Distirct** on "ON DUTY" basis with immediate effect until 2-4-6 Semesters of Academic year 2023-24 are completed.

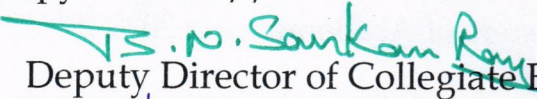
